# St. Baldrick's Foundation Official Sweepstakes Rules

**No purchase, payment, or financial contribution of any kind is necessary to enter or win this promotion.**

**Non-purchase entries and purchase entries have an equal chance of winning.**

1. Eligibility: The Sweepstakes is only open to legal residents of the United States and the District of Columbia who are 21 years of age or older at the time of entry. Void in Guam, Puerto Rico and all other U.S. territories and possessions and where prohibited. All donations from this Sweepstakes are the property of the non-profit organization the St. Baldrick's Foundation. This organization is a non-profit organization described in Section 501(c)(3) of the Internal Revenue Code. Employees of St. Baldrick's Foundation, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes.
